# Central Public Procurement Portal (CPPP)

Central Public Procurement Portal provides a single point access to all the tendering information on various procurement made across the country. It is integrated with Government eMarketplace and is called as GeM-CPPP. It hosts the Government eProcurement System (GePNIC®) for electronic procurement developed by National Informatics Centre in close coordination with Department of Expenditure, Ministry of Finance.

# It facilitates

**ePublishing:** Publishing of tender enquiries, corrigendum & award of contract details.

**XML:** Facilitates publishing the metadata of tenders published by organisations using varied eProcurement System.

**GeM Bids:** All the bids published on Government eMarket Place is also shown here.

**eProcurement:** Complete gamut of Procurement Goods, Works and Services including Global Tenders, Pre-Post integrations and is implemented in around 800+ Central Government Ministries / Departments and Public Sector Units, it is also used in 31 State Government/Union Territories for online tendering. Many World Bank and ADB tenders are processed using this GePNIC® platform.

# State in Focus



Government of Maharashtra adopted GePNIC in 2010, and since then the state processed over 4 lakh tenders worth more than ₹5 lakh crore.

Maharashtra is one of the states that has its own procurement rules—namely the Revised Manual of Office Procedures for Procurement (Dec 2016)—operated in harmony with central GFR/CVC/CPPP standards.

### The act includes provisions such as:

- The procurement frameworks integrate central-level rules, including General Financial Rules (GFR 2017) and CVC-CPPP guidelines, ensuring transparency and financial propriety.
- State-reserved provisions conflict or complement central rules; however, the overarching process aligns with national e-tendering standards.

# Revised Manual of Office Procedures for Procurement by Government Departments (enforced December 1, 2016)

- Mandatory for all procurement by state government departments.
- Includes standardized processes for e-tendering, single-source procurements, rate contracts, and technical bidding.
- Defines thresholds (e.g., goods > ₹1 lakh, works > ₹5 lakh) for compulsory e-procurement via GePNIC-based portals

### Maharashtra Manual of Office Procedure, 2023

- Updated administrative manual covering office workflows, file management, noting, drafting, and approval processes.
- Serves as the administrative backbone that supports and clarifies the procurement manual


