Central Public Procurement Portal (CPPP)

Central Public Procurement Portal provides a single point access to all the tendering information on various procurement made across the country. It is integrated with Government eMarketplace and is called as GeM-CPPP. It hosts the Government eProcurement System (GePNIC®) for electronic procurement developed by National Informatics Centre in close coordination with Department of Expenditure, Ministry of Finance.

It facilitates

ePublishing:

Publishing of tender enquiries, corrigendum & award of contract details.

XML:

Facilitates publishing the metadata of tenders published by organisations using varied eProcurement System.

GeM Bids:

Bids: All the bids published on Government eMarket Place is also shown here.

eProcurement:

Complete gamut of Procurement Goods, Works and Services including Global Tenders, Pre-Post integrations and is implemented in around 800+ Central Government Ministries / Departments and Public Sector Units, it is also used in 31 State Government/Union Territories for online tendering. Many World Bank and ADB tenders are processed using this GePNIC® platform.

Government of West Bengal adopted GePNIC for electronic procurement in 2011, and since then the state has processed over 19 lakh tenders worth more than ₹7 lakh crore.

The portal is being used by State Government Departments, Undertakings, Autonomous bodies including Zilla Parishad, Gorkha Territorial Administration and various Public Sectors across the State.

Acts & Rules for e-Procurement in West Bengal:

- **West Bengal Financial Rules (WBFR), Rule 177 (Amended 2014)** – Open tender is mandatory for works above ₹1 lakh; for works ₹5 lakh and above, e-tendering on wbtenders.gov.in is compulsory.
- **Two-Bid System (Rule 47C & Rule 177)** – For works above ₹10 lakh or technically complex procurements, a technical bid + financial bid system is mandatory.
- **EMD (Earnest Money Deposit) Rules** – Online payment of bid security is preferred; L1 bidder must submit hard copy along with acceptance. Failure can lead to blacklisting.
- **Tender Validity** – At least three tenders must be received; otherwise, re-tendering is required. Lowest valid tender is usually accepted unless Government approval allows otherwise.
- **Departmental Guidelines (2015 & onwards)** – All e-NITs must be published on both the centralized e-tender portal and departmental websites to ensure transparency and wider participation.

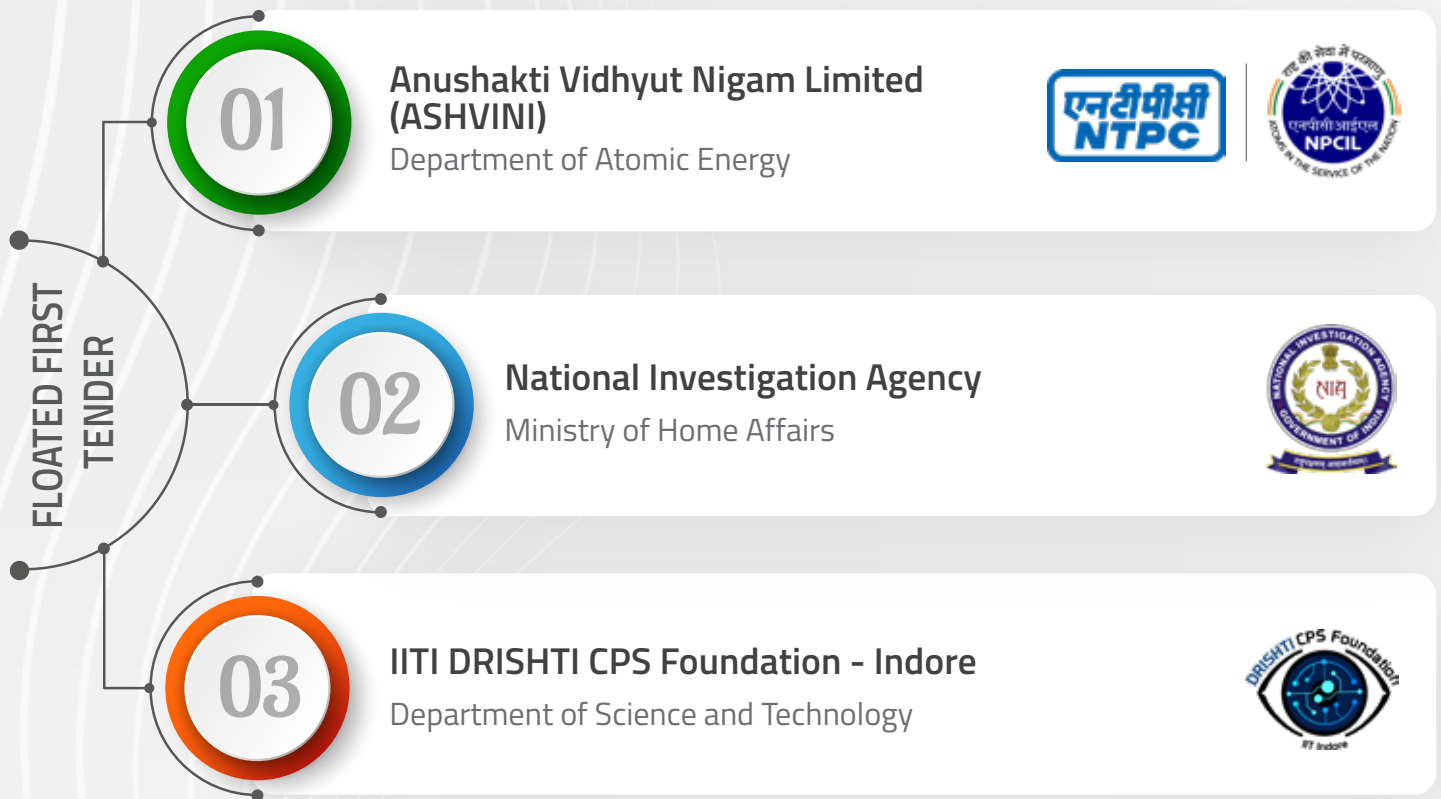
Publication Requirements – Tender notices must be published based on value:

- ₹1–5 lakh -> Notice board, website, 1 Bengali newspaper
- ₹5–10 lakh -> Add 1 English newspaper
- Above ₹10 lakh -> Add 1 Hindi newspaper + e-Procurement portal.

Minimum Bid Submission Periods – Time allowed for bidders:

- ≤₹10 lakh -> 7 days
- ₹10 lakh–₹1 crore -> 14 days
- Above ₹1 crore -> 21 days.
