Central Public Procurement Portal (CPPP)

Central Public Procurement Portal provides a single point access to all the tendering information on various procurement made across the country. It is integrated with Government eMarketplace and is called as GeM-CPPP. It hosts the Government eProcurement System (GePNIC®) for electronic procurement developed by National Informatics Centre in close coordination with Department of Expenditure, Ministry of Finance.

It facilitates :

- **ePublishing:** Publishing of tender enquiries, corrigendum & award of contract details.
- **GeM Bids:** All the bids published on Government eMarket Place is also shown here.
- **XML:** Facilitates publishing the metadata of tenders published by organisations using varied eProcurement System.
- **eProcurement:** Complete gamut of Procurement Goods, Works and Services including Global Tenders, Pre-Post integrations and is implemented in around 800+ Central Government Ministries / Departments and Public Sector Units, it is also used in 31 State Government/Union Territories for online tendering. Many World Bank and ADB tenders are processed using this GePNIC® platform.

Organisation in Focus



Oil and Natural Gas Corporation Limited (ONGC) is a Maharatna PSU engaged in exploration and production of oil and gas, contributing significantly to India’s energy security. ONGC utilizes the Central Public Procurement Portal (CPPP) as a centralized digital platform for publishing its procurement and tendering activities. The portal ensures transparency, efficiency, and accountability across ONGC’s tendering lifecycle.

Through CPPP, ONGC conducts end-to-end e-tendering, from bid publication to award of contract.

The platform strengthens competitive bidding and supports ONGC’s commitment to digital governance and best procurement practices.

The act includes provisions such as:

- **General Financial Rules (GFR) 2017:** Mandates all central government ministries, departments, and CPSEs (including ONGC) to publish and receive bids through an e-procurement platform, such as the Central Public Procurement Portal (CPPP) of NIC.
- **Rule 159 & Rule 160 of GFR 2017:** Require publication of tender notices and receipt of e-bids on the CPPP, ensuring transparent and electronic procurement processes.
- **Department of Expenditure Office Memorandums:** Series of OMs (e.g., from 2012, 2014, 2016) mandate the adoption of e-procurement for procurements above specified thresholds and provide guidelines for implementation.
- **Information Technology Act, 2000:** Digital Signature Certificates (DSCs) used for signing e-tender submissions are governed by this act and related rules, ensuring legal validity of electronic bids.
- **Procurement Manuals:** Manuals issued by the Department of Expenditure (e.g., Manual for Procurement of Goods & Services) outline procedures for e-procurement compliance as per government procurement rules.
